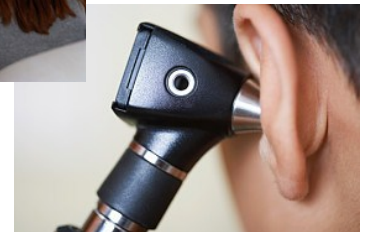
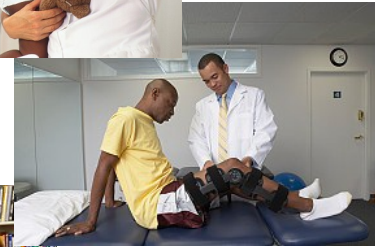

WHAT IS THE COALITION FOR PATIENTS' RIGHTS®?

The Coalition for Patients' Rights (CPR) was formed in 2006 and consists of more than 35 organizations representing a variety of licensed healthcare professionals.

The Coalition works to ensure that:

- Patients have direct access to the full scope of services offered by the healthcare providers of their choice.
- The American healthcare system's growing and increasingly diverse needs are met.

The Coalition is comprised of a diverse array of healthcare professionals that patients across the country rely upon, including advanced practice and registered nurses, audiologists, chiropractors, foot and ankle surgeons, naturopathic doctors, occupational therapists, physical therapists and psychologists.

ORGANIZED CAMPAIGN TO LIMIT PATIENTS' RIGHTS

Currently, there is a **divisive movement** to restrict access to the valuable services provided by many healthcare professionals.

Several medical groups have been working to restrict patients' access to services provided by healthcare professionals who are not doctors of medicine (MDs) or osteopathy (DOs).

The Scope of Practice Partnership (SOPP), an alliance of medical and osteopathic physician organizations, including the American Medical Association (AMA), aims to limit the ability of other healthcare professionals to offer services that they are educated, licensed and/or certified to provide.

Scope of practice battles threaten patient access to safe, high-quality and cost-effective healthcare.

WHAT'S AT STAKE?

As healthcare reform is implemented and there is an influx of newly insured patients, experts have expressed growing concern that there will not be enough healthcare professionals to meet the demand. Primary care providers already are in short supply, and the shortage is likely to grow worse.

If the needs of patients are to be successfully met, they must have access to a full range of healthcare professionals. In doing so, three key objectives can be addressed:

- Provide the best possible health and wellness outcomes for patients
- Provide needed care to patients, including those in rural and underserved areas
- Provide high-quality and cost-effective care
